## Keep HHW and Batteries Out

Household Hazardous Waste (HHW) cannot be put in any of your GreenWaste containers. HHW includes chemical cleaners, paints, oil, batteries, electronics, and products with warning labels like "Danger," "Caution," or "Poison."

Batteries (household\* & automotive)

Cleaning chemicals



Pool & spa chemicals

Motor oil & used filters



Propane canisters & fuel

\* Household batteries include AA, AAA, C, D, 6-volt, 9-volt, camera batteries, nickel cadmium and lithium ion.

# RECYCLE ORGANIC LANDFILL

## **Compliance Reminders**

#### Sort It Out



California AB 827 requires that businesses provide customers and employees with access to recycling and organic collection bins in direct proximity to garbage bins, with clear signage to assist in proper sorting.

### Skip The Stuff



California law AB 1276 requires all retail food facilities and food delivery platforms to provide single-use foodware accessories and condiments upon request only. This includes ramekin cups, utensils, stir sticks, chopsticks, straws, and condiment pouches.

### **Organics Diversion**



To help California reduce our production of climate pollutants, SB 1383 requires diversion of edible food to food-recovery programs, and separation of food scraps and plant matter from the garbage. 
